Ignition source 0 (Test 1):	The cigarette burnt out within 29 minutes, there was no flaming or progressive smouldering. (Pass)
Ignition source 0 (Test 2):	The cigarette burnt out within 30 minutes, there was no flaming or progressive smouldering. (Pass)
